Call to Order: Suzette Leonards @ 9:05AM

Called the meeting to order with roll call, noting there is a quorum.

Prayer - Wendy **Pledge of Allegiance** - Luke

Approve Meeting Minutes from August 14, 2025:

Nicole DeJean-Broussard made a motion to accept August 14, 2025, minutes as presented.

Financial Report: Nicole

Wendy and I worked on our financials, and I think we've gotten them much better. Our cash on hand right now is 189,201. We have a little bit of receivable funding from the occupancy tax. Investments at Charles Schwab is 162,000, which includes some cash. Profit and loss compared to the budget to actual. Total income right now is 94,000. Our budget for the year is 140,000. We're at 67% of that budget. When we started making an invoice we started using the occupancy tax category. We left the line with hotel motel tax revenue to show the amount collected there. We are working on setting up online payment system for all our occupancy tax payments, starting in Jan 2026. Luke Dupré made a motion to accept the financial report. Second by Chelsey Gallow Hopkins. Motion carried.

Director's Report/New Business: Wendy

- A. First item is to have the board declare the seat for Iota vacant and request the mayor of Iota to appoint a new member to the APTC board. Wendy: I sent Luke a letter and cc'ed Suzette and Cody before this meeting. After a lengthy discussion regarding Iota not having a representative who is able to attend the APTC monthly board meetings a motion was made by Nicole DeJean-Broussard to declare that the tourism seat vacant for the town of Iota and request the mayor of Iota or his representative fill the vacant seat. Wendy: I appreciate the motion. I don't want to table it. I would rather just deny this motion without a second. Allow Luke to talk to Cody and you will turn in your resignation before the September 2025 meeting, because it does look better for you. Suzette: This motion is denied due to lack of second. All in favor. Any nays? So, Moved. Chelsey: In the event Luke does not talk with Cody and/or turn in his resignation to Cody in the timing frame Luke has agreed too; is this back on the agenda? Wendy: YES

B. Proposed Policy & Procedure Changes: Under Compensation - Pay Procedures

Employees are paid by-weekly semi-monthly, on the 15th and the last day of the month. If pay day falls on either day falls on a weekend or holiday, the executive director will adjust pay day accordingly. employees will be paid the preceding workday. Any questions about salary or pay should be discussed with the executive director. Chellie Godeaux made a motion to make the written changes to reflect the changes we made in Feb 2025. Second by Nora Benoit. Motion carried.

Charles Schwab & LAMP Financial Investment – The bond was called a little bit earlier than the due date. We currently have around \$44,000/change in cash that's available to move to LAMP. At our July meeting we talked about possibly taking some of that money, I think \$40,000 to invest with LAMP. Chellie Godeaux made a motion to invest \$40,000 with the LAMP and review it in six months. Second by Marietta Leonards. Motion carried.

Marietta - German Fest in Roberts Cove - October 4th & 5th




Chellie Godeaux made a motion to adjourn the meeting. Second by Nora Benoit. Motion carried.
